2025 Christmas lighted parade guidelines

On behalf of the Madison County Chamber of Commerce we would like to thank you for participating in our annual Christmas lighted parade. The success of this parade depends on you. As in years past safety is our number one priority so we ask for your cooperation and following the official safety rules as distributed. The following guidelines assist you in your successful participation in our parade. If you do not adhere to the guidelines of the parade you will not be able to participate in the parade.

1. Max height is 15 feet
2. No "burn outs" or revving of engines with any vehicle or motorcycle
3. No passengers on the back of 4 Wheelers
4. All floats must have a walker or spotter. There must be one on each side of the float, lowboy, or trailer. This is for security purposes for the riders as well as parade spectators. This will help prevent small children from running up to, or under, floats to grab candy.
5. Candy should always be tossed at the feet of the parade spectators rather than directly at the crowd.
6. Parade departs Lake Madison Park promptly at 5:30 PM Saturday December 6 th so please be in line by 4:30 PM.
7. Must be able to provide proof of liability insurance on vehicle upon request
8. Only Christmas music is allowed to be played and only flags allowed on floats/vehicles are United States, Texas Flag, or Christmas themed flags.
9. **NO** Santa Claus allowed on entries! One Santa is at the end of parade on the fire truck.
